SECTION 4 - REQUIREMENTS FOR VOLUNTEER DRIVERS

The following policies are in effect for all volunteer drivers:

- 1. All drivers must be approved by the administration of Isaac Newton Christian Academy.
- 2. All drivers must be at least 25 years of age.
- 3. Adults who drive students on a school trip must complete this Volunteer Driver Application Form.
- 4. All drivers must possess a valid Iowa driver's license. A copy of the license will be kept on file in the school office.
- A copy of current proof of insurance on the vehicle being driven will be kept in the school office. The following are the minimum amounts of liability insurance coverage on the vehicle: (1) \$100,000 liability per person for bodily injury; (2) \$300,000 liability per incident for bodily injury for all vehicle occupants; and (3) \$50,000 liability for property damage.
- 6. Students riding in vehicles will be seated, and will be secured with individual, working seat belts, whether in the front seat or back seats. Children who are under 10 years of age and/or under 80 pounds will not be seated in the front seat.
- 7. The use of cell phones and other mobile devices while operating a motor vehicle for school-related activities and/or business is strictly prohibited.
- 8. When using your own vehicle, your liability and physical damage coverage is primary and the school's nonowned automobile liability insurance is secondary.
